INTRODUCTION

When you hire our services for photography, videography, plans etc. you pay a built-in license fee which grants you permission and the non-exclusive and non-transferable right to “Use” digital and printed copies of original files for a specific period of time and for a specific Use, in most cases, this is for the duration of the listing and for the listing alone. You can apply this to renting a hotel room or leasing a vehicle - you do not own the room or vehicle, you simply pay for the right to use it for a designated period.

OWNERSHIP

LEGAL

In the event that an infringement is discovered you will be notified by certified mail and invoiced the industry standard TRIPLE FEE (\$150 ext GST) for unauthorized usage to be paid within 30 days of receipt of said invoice. Additionally you could be prosecuted for Copyright Infringement in Australian Federal Court where you will be subject to a fine of statutory damages, actual damages and any additional profits as well as the court costs and legal fees.
